Introduction

Collected Information

- Information automatically collected Information such as location, IP addresses, domains and site activity are automatically collected through cookies. Use of Information

We may use collected information for one or more of the following purposes:

- To respond to your inquiries when contacting us.
- To better understand how and why our website is used for the purpose of improving future use by you and other site visitors, this may include research and analytics purposes.
- To provide you with news and newsletter updates, including new blog posts and events.
- To comply with applicable laws and regulations.
- For the purpose of system monitoring, effectiveness measurement, stability and debugging.
- For security and anti-fraud purposes.

Our organization is hosted on the Wix.com platform, therefore, your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. If you wish to no longer receive communication from us or if you request for your information to be deleted, we will maintain basic information about you to ensure we do not send you information in the future. We will also store any information required for administrative, legal or security purposes.

Cookies

As we mentioned above in the "Collected Information" section of our Policy, we, like most websites, use cookies and other tracking measures for a variety of reasons, including, but not limited to:

- Security and anti-fraud measures
- System monitoring, effectiveness management, stability and debugging
- To identify site member information and settings
- To track site analytics such as site traffic, visitor activity on and leaving our site and site performance
- To customize your site experience

There are different types of cookies used for certain purposes and stored for certain amounts of time. The cookies we may use include single-session and persistent.
